- (b) The supplier shall include an inspection report for all characteristics as defined on the drawings, purchase order and specifications.
- 7. The supplier shall provide a Certificate of Conformance with each shipment. This document shall contain at a minimum: the company name, purchase order number, item number, date, specification and / or drawing number, name of item, lot / batch number, quantity, revision and a factual statement that inspection / test data and chemical / physical analysis, traceable to the manufacturer is on file.
- 8. The supplier is to flow down to sub-tier suppliers the applicable requirements in the purchasing document, including key characteristics and applicable FOD control processes where required.
